Other Membership Terms

- NEGOTIATION ENGINE:** In order provide assurance to Vendors that Aboonda Members are serious about buying, a 20% escrow deposit is required by the 100 Members who participate in a negotiated offer, payable through PayPal. If Member accepts a negotiated offer, the 20% deposit is non-refundable and the 80% balance is debited from the Member's credit/debit card. If Member does not wish to participate in a negotiated offer for which he/she has made a 20% escrow deposit, Member may "opt out" of the offer within 48 hours of notification for a refund of escrow funds. If Member does not opt out within 48 hours initial notification, the offer is considered accepted and escrow funds are non-refundable.
- Member understands that Aboonda negotiates with many merchants in Member's city in order to obtain the best possible deal. Member also understands that the merchant that offers the best value may not be the Member's first choice, but agrees to keep an open mind while emphasizing "value" over a perfect solution.
- Member agrees that he/she is an Independent Business Owner, and not an employee, partner, legal representative, or franchisee of Aboonda, and is in no way entitled to benefits or considerations given to Aboonda employees, and shall not be treated as an employee for any purpose.
- Referral awards and any payments received by Member are considered income. Member agrees that he/she will be solely responsible for paying all expenses incurred in the pursuit of that income, including but not limited to travel, food, lodging, secretarial, office, long distance telephone, mobile telephone, and other expenses, INCLUDING ANY AND ALL APPLICABLE STATE AND FEDERAL TAXES.
