Overview

Vendor Options

Other Terms

- Volume Purchases:** Vendor is contacted when 100 Aboonda Members have made a deposit to purchase products and/or services sold by Vendor. Aboonda then negotiates pricing and "Special Favors & Privileges" with up to 5 competing Vendors; the most competitive bid – as determined by Members – wins. The winner of the bid is paid in advance for products and/or services, even though it may take weeks or months to perform the services.
- Aboonda Card Purchases:** Discount is taken at the point of sale via the buyer's Aboonda Card as the card is "swiped" on Vendor's POS system, and vendor is paid within via ACH within 48 hours.
- Vendor agrees that he/she is an Independent Business Owner, and not an employee, partner, legal representative, or franchisee of Aboonda, and is in no way entitled to benefits or considerations given to Aboonda employees, and shall not be treated as an employee for any purpose.
- Referral awards and any payments received by Vendor are considered income. Vendor agrees that he/she will be solely responsible for paying all expenses incurred in the pursuit of that income, including but not limited to travel, food, lodging, secretarial, office, long distance telephone, mobile telephone, and other expenses, INCLUDING ANY AND ALL APPLICABLE STATE AND FEDERAL TAXES.
